
Dear Ms. Irvine:

The purpose of this letter is to amend my ethics agreement signed on February 18, 2025. In my ethics agreement, I indicated that I may enter a contract with Cerberus Capital Management (CCM) to provide administrative services through April 15, 2026, which I did. I intended to transition to an outside provider in 2026, however, I have been unable to find a company to provide the services that I need. I will continue to contract for these services with CCM. Consequently, I am amending the fourth paragraph of Section II as follows:

Consistent with routine industry practice, each Cerberus Fund extends customary indemnity protections and Directors and Officers insurance to all current and former Cerberus Fund managers for their actions performed in connection with their positions in the funds. Consistent with the Funds' current policies and practice, after my resignation I will continue to be covered indefinitely by such indemnity protections from the Cerberus Funds and by Directors and Officers insurance that extend to both current and former Cerberus Fund managers. In addition, at the time of my resignation, I entered a written contract with CCM for the provision of certain administrative services that Cerberus previously has provided me (e.g., accounting and tax-related services) through April 15, 2026. Cerberus routinely provides tax compliance and accounting services to Cerberus executives, and it has provided me, as founder, with particularly extensive services for more than 25 years. I will extend this contract so that Cerberus will continue to provide these services to me, for which I will pay customary and reasonable fees. I also will enter into an agreement with CCM under which I will pay the full cost of continuing participation by my wife and me in CCM's health care benefit plan.

I have been advised that this amendment to my ethics agreement will be posted publicly, consistent with the public information law at 5 U.S.C. § 552, on the website of the U.S. Office of Government Ethics with ethics agreements of other Presidential nominees who file public financial disclosure reports.

Dear Ms. Irvine:

The purpose of this letter is to describe the steps that I will take to avoid any actual or apparent conflict of interest in the event that I am confirmed for the position of Deputy Secretary of Defense. It is my responsibility to understand and comply with commitments outlined in this agreement.

SECTION 1 – GENERAL COMMITMENTS

As required by the criminal conflicts of interest law at 18 U.S.C. § 208(a), I will not participate personally and substantially in any particular matter in which I know that I have a financial interest directly and predictably affected by the matter, or in which I know that a person whose interests are imputed to me has a financial interest directly and predictably affected by the particular matter, unless I first obtain a written waiver, pursuant to 18 U.S.C. § 208(b)(1), or qualify for a regulatory exemption, pursuant to 18 U.S.C. § 208(b)(2). I understand that the interests of the following persons are imputed to me:

- Any spouse or minor child of mine;
- Any general partner of a partnership in which I am a limited or general partner;
- Any organization in which I serve as an officer, director, trustee, general partner, or employee, even if uncompensated; and
- Any person or organization with which I am negotiating or have an arrangement concerning prospective employment.

In the event that an actual or potential conflict of interest arises during my appointment, I will consult with an agency ethics official and take the measures necessary to resolve the conflict, such as recusal from the particular matter or divestiture of an asset.

If I have a managed account or otherwise use the services of an investment professional during my appointment, I will ensure that the account manager or investment professional obtains my prior approval on a case-by-case basis for the purchase of any assets other than cash, cash equivalents, investment funds that qualify for the regulatory exemption for diversified mutual funds and unit investment trusts at 5 C.F.R. § 2640.201(a), obligations of the United States, or municipal bonds.

If I rely on a de minimis exemption under 5 C.F.R. § 2640.202 with regard to any of my financial interests in securities, I will monitor the value of those interests. If the aggregate value of interests affected by a particular matter increases and exceeds the de minimis threshold, I will not participate personally and substantially in the particular matter that to my knowledge has a

direct and predictable effect on the interests, unless I first obtain a written waiver pursuant to 18 U.S.C. § 208(b)(1).

I will receive a live ethics briefing from a member of the ethics office after my confirmation but not later than 7 days after my appointment pursuant to the ethics program regulation at 5 C.F.R. § 2638.305. Within 90 days of my confirmation, I will submit my Certification of Ethics Agreement Compliance which documents my compliance with this ethics agreement.

I will not modify this ethics agreement without your approval and the approval of the U.S. Office of Government Ethics (OGE) pursuant to the ethics agreement requirements contained in the financial disclosure regulation at 5 C.F.R. § 2634.803(a)(4).

SECTION 2 - CERBERUS CAPITAL MANAGEMENT L.P. AND RELATED ENTITIES

I am the Chief Executive Officer and principal equity owner of Cerberus Capital Management, L.P., and affiliated investment management companies (collectively, "CCM"). CCM manages a large number of investment funds and accounts (collectively, "Cerberus Funds"), which predominately are organized as limited partnerships. For ease of reference, I will refer in this ethics agreement to CCM, the Cerberus Funds, and related entities as "Cerberus," and the businesses in which Cerberus Funds have invested (debt and/or equity, including passive investments) as "Portfolio Companies." Neither in connection with, nor after my separation from Cerberus will I receive any severance or bonus payment.

Upon confirmation, I will resign from my positions with Cerberus Capital Management, L.P. and related Cerberus entities designated in Appendix A.

Prior to assuming the duties of the position of Deputy Secretary, I will divest all of my interests in Cerberus including, but not limited to, my equity interest, carried interest, incentive fees/allocations, and capital commitments that are set forth in Appendix B. Such divestiture may include a gift to one or more irrevocable trusts established for the benefit of my adult children, in which neither my wife nor I have any financial interest, and/or for the benefit of one or more public charities. I will not be the trustee for any of these trusts. The trustees of these trusts will be solely responsible for their administration, including any distributions either to my children or to charity. The trusts will pay all income tax on its earnings on my behalf and will pay any taxes that result from making the tax payment on my behalf. I will not participate personally and substantially in any particular matter that to my knowledge has a direct and predictable effect on the ability or willingness of any trust to pay the taxes on my behalf, unless I first obtain a written waiver, pursuant to 18 U.S.C. § 208(b)(1). I have verified that I will be able to carry out the divestitures within the timeframe described above.

Consistent with routine industry practice, each Cerberus Fund extends customary indemnity protections and Directors and Officers insurance to all current and former Cerberus Fund managers for their actions performed in connection with their positions in the funds. Consistent with the Funds' current policies and practice, after my resignation I will continue to be covered indefinitely by such indemnity protections from the Cerberus Funds and by Directors and Officers insurance that extend to both current and former Cerberus Fund managers. In addition, at the time of my resignation, I may enter a written contract with CCM for the

provision of certain administrative services that Cerberus previously has provided me (e.g., accounting and tax-related services) through April 15, 2026. Cerberus routinely provides tax compliance and accounting services to Cerberus executives, and it has provided me, as founder, with particularly extensive such services for more than 25 years. In order to enable an orderly transition to outside providers, Cerberus will continue to provide these services to me, for which I will pay customary and reasonable fees. I also will enter into an agreement with CCM under which I will pay the full cost of continuing participation by my wife and me in CCM's health care benefit plan.

I will not participate personally and substantially in any particular matter that to my knowledge has a direct and predictable effect on the ability or willingness of CCM to provide these services or benefits to me, unless I first obtain a written waiver, pursuant to 18 U.S.C. § 208(b)(1). In addition, pursuant to the impartiality regulation at 5 C.F.R. § 2635.502, for a period of one year after my resignation from Cerberus and its related entities, or for as long as these services or benefits are being provided to me, whichever is later, I will not participate personally and substantially in any particular matter involving specific parties in which I know that Cerberus or a related entity is a party or represents a party, unless I am first authorized to participate, pursuant to 5 C.F.R. § 2635.502(d). I also will not participate personally and substantially in any particular matter involving specific parties in which I know a former client of mine is a party or represents a party for a period of one year after I last provided service to that client, unless I am first authorized to participate, pursuant to 5 C.F.R. § 2635.502(d).

Upon confirmation, I will resign from my position with Albertsons Companies Inc. I own unvested restricted stock units ("RSUs") which will vest on February 22, 2025, with a corresponding distribution of common stock to me. Prior to assuming the duties of the position of Deputy Secretary, I will divest all of my Albertsons stock to CCM.

Other than Albertsons, I do not hold any positions with Portfolio Companies and I do not hold stock options, restricted stock, or RSUs issued by Cerberus or any Portfolio Company.

SECTION 3 – FAMILY INVESTMENT ENTITIES

Upon confirmation, I will resign my position with the following entities:

- Tracker Capital Management, LLC
- Feinberg Family GP, L.P.
- Feinberg Family, LLC

Prior to assuming the duties of the position of Deputy Secretary, I will divest all of my interests in these entities and my financial interest in Feinberg Family Institutional LLC. Such divestiture may include a gift to one or more irrevocable trusts established for the benefit of my adult children, in which neither my wife nor I have any financial interest, and/or for the benefit of one or more public charities. I will not be the trustee for any of these trusts. The trustees of these trusts will be solely responsible for their administration, including any distributions either to my children or to charity. The trusts will pay all income tax on its earnings on my behalf and will pay any taxes that result from making the tax payment on my behalf. I will not participate personally and substantially in any particular matter that to my knowledge has a direct and

predictable effect on the ability or willingness of any trust to pay the taxes on my behalf, unless I first obtain a written waiver, pursuant to 18 U.S.C. § 208(b)(1). I have verified that I will be able to carry out the divestitures within the timeframe described above. Pursuant to the impartiality regulation at 5 C.F.R. § 2635.502, for a period of one year after my resignation from each of these entities, I will not participate personally and substantially in any particular matter involving specific parties in which I know that entity is a party or represents a party, unless I am first authorized to participate, pursuant to 5 C.F.R. § 2635.502(d).

SECTION 4 – FAMILY TRUSTS

Prior to assuming the duties of the position of Deputy Secretary, I will divest all of my interests in Family Trusts #1-5. Such divestiture may include a gift to one or more irrevocable trusts established for the benefit of my adult children, in which neither my wife nor I have any financial interest, and/or for the benefit of one or more public charities. I will not be the trustee for any of these trusts. The trustees of these trusts will be solely responsible for their administration, including any distributions either to my children or to charity. The trusts will pay all income tax on its earnings on my behalf and will pay any taxes that result from making the tax payment on my behalf. I will not participate personally and substantially in any particular matter that to my knowledge has a direct and predictable effect on the ability or willingness of any trust to pay the taxes on my behalf, unless I first obtain a written waiver, pursuant to 18 U.S.C. § 208(b)(1). I have verified that I will be able to carry out the divestitures within the timeframe described above.

SECTION 5 – ADDITIONAL DIVESTITURES

Prior to assuming the duties of the position of Deputy Secretary, I will divest my interest in the entities listed in Appendix C. Such divestiture may include a gift to one or more irrevocable trusts established for the benefit of my adult children, in which neither my wife nor I have any financial interest, and/or for the benefit of one or more public charities. I will not be the trustee for any of these trusts. The trustees of these trusts will be solely responsible for their administration, including any distributions either to my children or to charity. The trusts will pay all income tax on its earnings on my behalf and will pay any taxes that result from making the tax payment on my behalf. I will not participate personally and substantially in any particular matter that to my knowledge has a direct and predictable effect on the ability or willingness of any trust to pay the taxes on my behalf, unless I first obtain a written waiver, pursuant to 18 U.S.C. § 208(b)(1). I have verified that I will be able to carry out the divestitures within the timeframe described above.

I (including my spouse and minor children if applicable) will not repurchase any asset I was required to divest without consulting with my agency ethics official and the U.S. Office of Government Ethics.

SECTION 6 – RETAINED POSITIONS

I will retain my position with the following entities:

- Albany Ranch LLC
- Kidney Creek Farms LLC
- NYC 67th Street LLC
- October Farms Properties, LLC

I will not at any time receive compensation for services that I perform during my Federal appointment. I will not participate personally and substantially in any particular matter that to my knowledge has a direct and predictable effect on the financial interests of any of these entities or their underlying holdings, unless I first obtain a written waiver pursuant to 18 U.S.C. § 208(b)(1).

SECTION 7 – BUFFALO HORN PROPERTIES LLC

My wife and I own Buffalo Horn Properties, LLC. Upon confirmation, I will resign from my position with Buffalo Horn Properties, LLC. I will continue to have a financial interest in this entity, but I will not provide services material to the production of income. Instead, I will receive only passive investment income from it. I will not participate personally and substantially in any particular matter that to my knowledge has a direct and predictable effect on the financial interests of Buffalo Horn Properties, LLC, unless I first obtain a written waiver, pursuant to 18 U.S.C. § 208(b)(1).

SECTION 8 – OTHER POSITIONS

Upon confirmation, I will resign from my positions with the entities designated in Appendix D “Other Positions.” Prior to assuming the duties of the position of Deputy Secretary, I will divest my interest in these entities. Such divestiture may include a gift to one or more irrevocable trusts established for the benefit of my adult children, in which neither my wife nor I have any financial interest, and/or for the benefit of one or more public charities. I will not be the trustee for any of these trusts. The trustees of these trusts will be solely responsible for their administration, including any distributions either to my children or to charity. The trusts will pay all income tax on its earnings on my behalf and will pay any taxes that result from making the tax payment on my behalf. I will not participate personally and substantially in any particular matter that to my knowledge has a direct and predictable effect on the ability or willingness of any trust to pay the taxes on my behalf, unless I first obtain a written waiver, pursuant to 18 U.S.C. § 208(b)(1). I have verified that I will be able to carry out the divestitures within the timeframe described above. Pursuant to the impartiality regulation at 5 C.F.R. § 2635.502, for a period of one year after my resignation from each of these entities, I will not participate personally and substantially in any particular matter involving specific parties in which I know that entity is a party or represents a party, unless I am first authorized to participate, pursuant to 5 C.F.R. § 2635.502(d).

SECTION 9 - OTHER COMMITMENTS

In addition to the impartiality regulation at 5 C.F.R. § 2635.502, I understand that as an employee of the Department of Defense I will be required to comply with Section 1117 of the National Defense Authorization Act for Fiscal Year 2022. Therefore, for a period of two years after my resignation from any organization, including a trade organization, for which I served as an employee, officer, director, trustee, or general partner, I will not knowingly participate personally and substantially in any particular matter involving specific parties in which that organization is a party or represents a party to the matter, unless I am authorized to participate, pursuant to Section 1117(b).

SECTION 10 – PUBLIC POSTING

I have been advised that this ethics agreement and the Certification of Ethics Agreement Compliance will be posted publicly, consistent with the public information law at 5 U.S.C. § 552, on the website of the U.S. Office of Government Ethics with ethics agreements of other presidential nominees who file public financial disclosure reports.
