Re: Ethics Undertakings

#### Dear Mr. Visek:

The purpose of this letter is to describe the steps that I will take to avoid any actual or apparent conflict of interest in the event that I am confirmed for the position of Under Secretary of State for Economic Growth, Energy, and the Environment at the Department of State. It is my responsibility to understand and comply with commitments outlined in this agreement.

#### SECTION 1 – GENERAL COMMITMENTS

If confirmed as Under Secretary, as required by the criminal conflicts of interest law at 18 U.S.C. § 208(a), I will not participate personally and substantially in any particular matter in which I know that I have a financial interest directly and predictably affected by the matter, or in which I know that a person whose interests are imputed to me has a financial interest directly and predictably affected by the particular matter, unless I first obtain a written waiver, pursuant to 18 U.S.C. § 208(b)(1), or qualify for a regulatory exemption, pursuant to 18 U.S.C. § 208(b)(2). I understand that the interests of the following persons are imputed to me:

- Any spouse or minor child of mine;
- Any general partner of a partnership in which I am a limited or general partner;
- Any organization in which I serve as an officer, director, trustee, general partner, or employee, even if uncompensated; and
- Any person or organization with which I am negotiating or have an arrangement concerning prospective employment.

In addition, I will recuse myself from participation on a case-by-case basis in any particular matter involving specific parties in which I determine that a reasonable person with knowledge of the relevant facts would question my impartiality in that matter, unless I am first authorized to participate, pursuant to the impartiality regulations at 5 C.F.R. Part 2635, Subpart E.

In the event that an actual or potential conflict of interest arises during my appointment, I will consult with an agency ethics official and take the measures necessary to resolve the conflict, such as recusal from the particular matter or divestiture of an asset.

I have managed accounts, and I will direct the account managers to obtain my prior approval on a case-by-case basis for the purchase of any assets other than cash, cash equivalents, investment funds that qualify for the regulatory exemption for diversified mutual funds and unit investment trusts at 5 C.F.R. § 2640.201(a), obligations of the United States, or municipal bonds. I will monitor whether the account manager is following this direction regarding prior approval.

I will receive a live ethics briefing from a member of the ethics office after my confirmation but not later than 15 days after my appointment pursuant to the ethics program regulation at 5 C.F.R. § 2638.305. Within 90 days of my confirmation, I will submit my Certification of Ethics Agreement Compliance which documents my compliance with this ethics agreement.

I will not modify this ethics agreement without your approval and the approval of the U.S. Office of Government Ethics pursuant to the ethics agreement requirements contained in the financial disclosure regulation at 5 C.F.R. § 2634.803(a)(4).

#### SECTION 2 - OUTBUILD LLC

I am the managing member of my consulting firm, Outbuild Consulting LLC. Upon confirmation, my consulting firm will cease engaging in any business, including the representation of clients. During my appointment to the position of Under Secretary, the firm will remain dormant and will not advertise. I will not perform any services for the firm, except that I will comply with any court orders or subpoenas and any requirements involving legal filings, taxes, and fees that are necessary to maintain the firm while it is in an inactive status. As Under Secretary, I will not participate personally and substantially in any particular matter that to my knowledge has a direct and predictable effect on the financial interests of Outbuild Consulting LLC. In addition, pursuant to the impartiality regulation at 5 C.F.R. § 2635.502, I will not participate personally and substantially in any particular matter involving specific parties in which I know a former client of mine is a party or represents a party for a period of one year after I last provided service to that client, unless I am first authorized to participate, pursuant to 5 C.F.R. § 2635.502(d).

## SECTION 3 - PALANTIR, INC.

Upon confirmation, I will resign from my position as Senior Adviser to the CEO of Palantir, Inc. I hold stock in Palantir. I do not hold stock options, restricted stock, restricted stock units, or any other equity in Palantir. I will divest my stock holdings in Palantir as soon as practicable but not later than 90 days after my confirmation. I will not participate personally and substantially in any particular matter that to my knowledge has a direct and predictable effect on the financial interests of Palantir until I have divested my stock holdings, unless I first obtain a written waiver, pursuant to 18 U.S.C. § 208(b)(1), or qualify for a regulatory exemption, pursuant to 18 U.S.C. § 208(b)(2). I have verified that I will be able to carry out the divestitures within the timeframe described above. Pursuant to the impartiality regulation at 5 C.F.R. § 2635.502, for a period of one year after my resignation, I will not participate personally and substantially in any particular matter involving specific parties in which I know Palantir, Inc., is a party or represents a party, unless I am first authorized to participate, pursuant to 5 C.F.R. § 2635.502(d).

### SECTION 4 – OTHER RESIGNATIONS

Upon confirmation, I will resign my position as Senior Adjunct Fellow at the Center for a New American Security. Pursuant to the impartiality regulation at 5 C.F.R. § 2635.502, for a period of one year after my resignation, I will not participate personally and substantially in any particular matter involving specific parties in which I know the Center for a New American Security is a party or represents a party, unless I am first authorized to participate, pursuant to 5 C.F.R. § 2635.502(d).

### SECTION 5 – DIVESTITURES

As soon as practicable but not later than 90 days after my confirmation, I and my spouse will divest our interests in the entities listed in Attachment A. With regard to each of these entities, I will not participate personally and substantially in any particular matter that to my knowledge has a direct and predictable effect on the financial interests of the entity until I have divested it, unless I first obtain a written waiver, pursuant to 18 U.S.C. § 208(b)(1), or qualify for a regulatory exemption, pursuant to 18 U.S.C. § 208(b)(2). I have verified that we will be able to carry out the divestitures within the timeframe described above.

I understand that I may be eligible to request a Certificate of Divestiture for qualifying assets and that a Certificate of Divestiture is effective only if obtained prior to divestiture. Regardless of whether I receive a Certificate of Divestiture, I will ensure that all divestitures discussed in this agreement occur within the agreed upon timeframes and that all proceeds are invested in non-conflicting assets. I understand that I must submit my request for a Certificate of Divestiture to allow for adequate time for OGE to process the Certificate of Divestiture, and in order to divest assets within the agreed upon timeframe.

I (including my spouse and minor children if applicable) will not repurchase any asset I was required to divest without consulting with my agency ethics official and the U.S. Office of Government Ethics.

## SECTION 6 - SPOUSE EMPLOYMENT AND RETAINED INTERESTS

My spouse is Managing Director of the venture capital firm Khosla Ventures. For as long as my spouse continues to work for Khosla Ventures, I will not participate personally and substantially in any particular matter that to my knowledge has a direct and predictable effect on the financial interests of the firm, unless I first obtain a written waiver, pursuant to 18 U.S.C. § 208(b)(1).

My spouse previously worked as General Partner of the venture capital firm Founders Fund. Through his employment with Khosla Ventures and Founders Fund, my spouse was provided equity ownership and carried interest in the funds listed in Attachment B. As a result of my spouse's employment, it is possible that he will receive additional equity and carried interests in private equity funds.

I understand the duties of the position of Under Secretary could involve particular matters affecting the financial interests of companies held in these funds. The Department of State has

advised that my recusal from particular matters in which my financial interest would otherwise pose a conflict of interest will not substantially limit my ability to perform the essential duties of the position of Under Secretary. In particular, I expect to work in such policy priority areas as: promoting exports of U.S. oil and gas to energy-constrained allies and partners; partnering with the Development Finance Corporation to secure America's access to critical minerals and rare earths in foreign countries' jurisdictions; scrutinizing China's "Development Country Status" at the World Trade Organization and its abuse of low-interest loans provided by the International Monetary Fund and the World Bank (and underwritten by U.S. taxpayers) to fund its Belt & Road Initiative projects; working with the Deputy Secretary to enlist and leverage U.S. ambassadors and economic officers around the world to advance measurable economic objectives and collect economic intelligence to inform the Secretary's decision-making on economic security; promoting normalization of relations between Israel and Saudi Arabia through deeper economic integration; accelerating efforts to revitalize the U.S. industrial base by incentivizing foreign manufacturing companies to expand their manufacturing activities in the United States; engaging North Atlantic partners to safeguard America's vital economic interest there and in the Artic; engaging in the interagency process on CFIUS; and supporting sanctions designations.

As the Designated Agency Ethics Official for the Department of State, you have advised me that it is permissible for my spouse to maintain his interests in these funds subject to the following conditions:

First, to avoid violating 18 U.S.C. § 208, I will not participate personally and substantially in any particular matter that to my knowledge has a direct and predictable effect on the financial interests of the funds or its underlying holdings, which includes the companies identified in all the sectors listed on Attachment B. This includes particular matters of general applicability, which you have explained are matters that involve or affect the interests of a discrete and identifiable class of companies. I commit to consulting as necessary with State Department ethics officials regarding matters that could potentially affect the companies listed in Attachment B as part of the screening process set out below.

Second, because of my spouse's continued interest in these funds and the remit of the Under Secretary position, I understand that there is a heightened risk of a conflict of interest arising from matters involving the following sectors: artificial intelligence software; space technology; cybersecurity; digital currencies, including platforms for trading; financial technology; renewable energy development; consumer and enterprise technology; digital health, medical technology, diagnostics, and therapeutics; and edge networking.

Third, I have agreed to enter into a comprehensive screening process to ensure that I do not inadvertently violate 18 U.S.C. § 208. To effectuate this screening arrangement, I have agreed to provide the State Department with all necessary information and to abide by their direction concerning when it is my responsibility to recuse from government matters, including updates to the list of companies on Attachment B based on any changes to the portfolios of the funds which I or my spouse is made aware. Notwithstanding this arrangement, I understand it is my personal responsibility to remain vigilant in identifying and recusing from any particular matters that could have a direct and predictable effect on the financial interests of the funds and their

holdings, including both particular matters involving specific parties and particular matters of general applicability.

Finally, I understand that I am prohibited from sharing nonpublic information with my spouse.

### SECTION 7 - PUBLIC POSTING

I have been advised that this ethics agreement and the Certification of Ethics Agreement Compliance will be posted publicly, consistent with the public information law at 5 U.S.C. § 552, on the website of the U.S. Office of Government Ethics with ethics agreements of other Presidential nominees who file public financial disclosure reports.
