



The Office of the White House Counsel is forwarding you a priority request from Kenneth I. Juster for a Certificate of Divestiture (CD) for numerous assets, including his interests in several (b)(6). Mr. Juster, the Deputy Assistant to the President for International Economic Affairs, (b)(5), (6)

He and his private financial management team have been very helpful in providing the necessary information to properly report his holdings and Mr. Juster is eager to divest the moment a CD is issued by your office in order to ensure that there is no possibility of a financial conflict of interest.

Attached, please find the formal request from Mr. Juster pursuant to 5 CFR 2634.1005(a) as well as our office's formal request to OGE pursuant to 5 CFR 2634.1005(b). The second attachment is a copy of Mr. Juster's signed (but not yet certified) financial disclosure report. The third attachment is not required, but may be helpful in expediting your analysis - it is a document provided by his accountant listing the assets Mr. Juster desires to keep and therefore is not requesting a CD. I'll call your attention to the (b)(3), (6) in the third section of this document. OGE General Counsel David Apol has suggested that we provide a brief explanation of those (b)(3),(6) and Mr. Juster's accountant is working on it and we will provide it to you by separate e-mail.


