

The U.S. Office of Government Ethics (OGE) has not located any records responsive to your Freedom of Information Act (FOIA) request, which OGE received on June 2, 2021 and assigned tracking number OGE FOIA FY 21/046. In your request, you asked for "all un-classified emails between October of 2020 through January 6th of 2021 belonging to various congressional leaders and the President of the United States. I am requesting Trump's emails along with the emails belonging to Rep. Marjorie Taylor Greene, Rep. Lauren Boebert, Rep. Kevin McCarthy, Rep. Steve Scalis, Rep. Elise Stefanik, Rep. Matt Gaetz, Sen. Mitch McConnell, Sen. Rick Scott, and Sen. Lindsey Graham." On June 4, 2021, you clarified that you are asking for emails exchanged among the Congress members and that you are not asking for emails exchanged between OGE and Congress members and/or former President Donald Trump.

The OGE official responsible for this FOIA determination is the undersigned. In accordance with the FOIA, as codified at 5 U.S.C. § 552(a)(6)(A), and OGE's updated FOIA regulations, at 5 C.F.R. § 2604.304, you may administratively appeal to the Program Counsel, U.S. Office of Government Ethics, 1201 New York Avenue, N.W., Suite 500, Washington, DC 20005-3917. Any such appeal must be in writing and must be sent within 90 days of the date you receive this response letter. If you do appeal, you should include copies of your request and this response, together with a statement of why you believe this initial determination is in error. Also, if you appeal, you should clearly indicate on the envelope and in the letter that it is a "Freedom of Information Act Appeal."
