You have asked whether you may participate in discussions about the applicability of 18 USC 208 to people who have student loans and are assigned to participate in discussions related to student loan forgiveness. The subject discussions could relate to forgiveness of student loans in general, or to the forgiveness of student loans for public service. You ask because you personally are responsible for some student loans taken out for your children's education.

We think it is clear that your holding of student loans does not prohibit you from participating in this matter. The matter you are being asked to participate in is not whether or not student loans should be forgiven, or how such forgiveness will be accomplished. The matter you are participating in relates to whether others, whose identities you do not know, may participate in the matter related to forgiveness. The resolution of that matter will have no direct and predictable effect on your financial interests.


