Government Executive reports that Rep. Dan Newhouse has joined a nascent effort to issue upwards of 30% pay cuts to federal employees who engage in regular telework by depriving them of their locality pay. The article notes that the congressman introduced the Federal Employee Return to Work Act (H.R. 10014), a measure that would bar federal employees who spend at least one day per week on telework from receiving the locality pay determined by the location of their official work station, instead considering them part of the "Rest of U.S." locality pay area, regardless of where they live or work. A Senate bill targeting teleworkers' locality pay now has its companion in the House

Government Executive reports that federal workers' views of their employer in general slightly

Following leader remarks, the Senate will resume consideration of the nomination of Adam B. Abelson to be a U.S. district judge for the district of Maryland. At 5:30 p.m., the Senate will vote on agreeing to the Schumer, D-N.Y., motion to invoke cloture on the Abelson nomination.

## **Case of Interest**

Killebrew v. Department of Transportation (MSPB; Nonprecedential). The MSPB upheld the removal of an employee for, among other things, failing to disclose his outside position as proprietor of a private company and violating 18 USC 203. Of interest, the MSPB upheld the charge that there was a violation of 18 USC 203, even though there was no interaction with the government. The MSPB determined that there was a violation when the employee sought payment for compliance matters before the Federal Motor Carrier Safety Administration, even if those representational acts never occurred.
