

Should the final reviewer notes be added to FDTS? It's not listed in the procedures for reviewers to do so.

In addition, #20 in the candidate procedures says "20. The appropriate branch uploads a copy to FDTS. If PNB reviewed the report, PNB will send an e-mail to the IFDB requesting that they place the candidate's name on the OGE website." Candidate reports are no longer being posted separately on OGE's website. They are uploaded as a support document just like all other 278s and pulled into the 201 system. The highlighted sentence should be removed from the procedures.

It's not listed in the procedure so I wanted to check, do you want the FEC transmittal letter and/or the email from FEC transmitting the report to OGE uploaded as support docs to FDTS?

Lastly, I noticed there seems to be a lot of concern regarding timing when it comes to candidate reports. #11 in the candidate procedures says "11. The appropriate branch scans the report, sends a copy to the FEC, and uploads a copy to FDTS."
