Mr. Lotfullah Najafizada (Afghanistan), 29, is an award-winning journalist and Director of TOLONews, Afghanistan's top 24/7 news and current affairs television channel. At TOLONews, he oversees the largest news operation in Afghanistan with a newsroom of over 100 journalists and media professionals in Kabul and bureaus around the country, producing about 18 hours of television content per day. During his journalism career, Mr. Najafizada has conducted many high profile TV interviews with global leaders, including President Ashraf Ghani, Chief Executive Abdullah Abdullah, former British Prime Minister David Cameron, NATO Secretary General Jens Stoltenberg, and former Commander of the International Security Assistance Force and U.S. Forces in Afghanistan,

General John Allen. Previously, Mr. Najafizada worked for the NATO mission in Afghanistan, providing strategic communications services. In 2010, as a World Press Institute Fellow, Mr. Najafizada conducted research on the U.S. mid-term elections. In 2012, he was selected by the Asia Society for a class of the Asia 21 Young Leaders Initiative. On World Press Freedom Day 2016, *Reporters Without Borders* awarded Mr. Najafizada with the prestigious medal of Press Freedom Hero for his fight for free press in Afghanistan. Mr. Najafizada holds a B.Sc. in Economics from Kardan University in Kabul (2012) and has completed journalism trainings in the U.K. and the U.S. Research topic: "*How Free Media in Afghanistan Revolutionized a Society Silenced for Decades.*"

Mr. Sami Sadat (Afghanistan), 31, is the CEO of Blue Sea Logistics Company, a Kabul based company that supplies defense equipment and technology to Afghan forces. From 2013-15, Mr. Sadat served at the National Directorate of Security (NDS) as Deputy Director for Intelligence Analysis and then as Director of Covert Influence Operations. From 2012-13 he served as Director for Strategic Communications at the High Peace Council and from 2007-10 Mr. Sadat worked at the Ministry of Interior of Afghanistan as Deputy Director for Strategic Communications and then as Policy Adviser to the Minister. Mr. Sadat is a graduate of the NATO Military Academy in Munich, Germany (2007) and the Polish Defense Academy where he completed Battalion Command Course (2010).

Mr. Sadat also studied at the Joint Services Command and Staff College at the Defense Academy of the United Kingdom, from which he graduated in 2011 with the highest distinction as the youngest ever graduate, known as *Arkani Harb* in Afghanistan. In addition, Mr. Sadat holds a MA in Strategic Management and Leadership from the U.K. Charter Management Institute (2012). Mr. Sadat is the author of a number of opinion and policy papers published in various national and international media outlets. 

Thank you very much, Wendy. Here goes the bio:

Laura Alonso is Secretary of Public Ethics, Transparency and Fight against corruption, in charge of the Anticorruption Office (Argentina). She ran for office in 2009 and was reelected to Argentine Congress in 2013. She was executive director of the NGO PoderCiudadano, the Argentine chapter of Transparency International. In 2012, Laura Alonso was selected Young Global Leader of the World Economic Forum and as a Fellow at the Draper Hills Democracy and Development Program at the University of Stanford.
