Subject: (b) (5): Draft OMB Guidance for Implementing the PMIAA

PIOs / Deputy PIOs:

As you know, OMB is currently in the process of developing guidance for implementing the Program Management Improvement Accountability Act (PMIAA). Enacted in December, 2016, the law aims to further strengthen the performance of the Federal Government through improved program and project management. OMB's draft guidance is based on an earlier prototype circulated for agency comment, and incorporates agency and stakeholder feedback.

**How to Review and Comment on Draft OMB Guidance:** OMB's draft implementation guidance is posted for agency review on the PMIAA MAX community page at (b) (6). Please provide any comments or feedback on the draft guidance (b) (5).

Instructions for providing comments are posted on the PMIAA MAX (b) (6). OMB will use this MAX Community page for communicating with agencies on PMIAA implementation, facilitating the socialization of key policy proposals in the draft guidance, as well as timeline and next steps, etc. OMB will issue initial implementation guidance for the PMIAA in (b) (5).

**Summary Overview:** OMB's initial implementation guidance focuses on:

- outlining key strategies and milestones for improving program management as part of a 5-

year strategic plan;

- establishing a coordinated governance structure for overseeing the law's implementation;
- establishing government-wide standards and practices for program management that are generally applicable across all types of programs implemented by agencies;
- piloting Portfolio Reviews in the area of non-IT major acquisition programs; and
- efforts to build program management capacity and capabilities overtime across the PM workforce.
