Dear Mr. Chairman:

On August 11, 2025, the Office of Government Ethics (OGE) sent a letter to the Committee regarding the ethics agreement for Scott Bessent, Secretary of the Department of the Treasury (Treasury). This letter supplements the information provided in that letter.

Treasury ethics officials have provided OGE with additional information regarding the Secretary's ethics agreement. The ethics officials informed OGE that the Secretary is committed to complying with the remaining asset divestitures identified in his ethics agreement by December 15, 2025. The ethics officials explain that the assets are illiquid and are not readily marketable. They add that excluding the farmlands, the assets also have significant restrictions on who can acquire them and that the Secretary has been working to divest them since his confirmation in January 2025.

Treasury ethics officials also confirmed that the Secretary has been and will continue to be recused from particular matters affecting these assets. To effectuate these recusals, Treasury ethics staff has provided the Secretary's front office with a screening memorandum for them to identify potentially conflicting matters that would be seen by the Secretary.

Dear Mr. Chairman:

In accordance with U.S. Office of Government Ethics' (OGE) policy and Program Advisory PA-19-09, I am notifying you that Scott Bessent, Secretary of the Department of the Treasury (Treasury), has failed to timely comply with certain terms of the ethics agreement he signed and that OGE previously provided to your office for consideration during his confirmation process. Mr. Bessent was confirmed on January 27, 2025, and was required to comply with certain provisions of his ethics agreement by April 28, 2025. He was also required to submit a Certification of Ethics Agreement Compliance (Certification) to certify that he had complied with these provisions by May 5, 2025.

The Secretary submitted an initial Certification on May 5, 2025, indicating partial compliance. In consultation with OGE and ethics officials at Treasury, the Secretary amended his ethics agreement on May 2, 2025, and June 5, 2025. These amendments were transmitted to you on May 5, 2025, and July 17, 2025, respectively. OGE has become aware the Secretary will need to further amend his ethics agreement. We are awaiting additional information from the Secretary and the agency ethics official. There is currently no timeline for resolution.

OGE will continue to monitor the status of the Secretary's compliance with his ethics agreement. OGE has also advised Treasury's ethics officials to emphasize to the Secretary that it is his personal responsibility to avoid taking any action that could create a real or apparent conflict of interest with regard to his holdings.

Dear Mr. Vetter:

The purpose of this letter is to amend my ethics agreement signed on January 9, 2025. To expedite my ethics review, I agreed to divest most of my securities holding other than diversified mutual funds and Treasury securities. In that agreement, I stated that I would divest the following assets:

- Presight RV Co-Invest Fund, LP (private equity fund; no knowledge of underlying holdings)
- Half Acre WSW, LLC (investment in Waterloo Sparkling Water, a privately held domestic small company that manufactures and distributes flavored water for consumers)
- Cambrian Biopharma (Series A & Series C) (privately held clinical stage drug development company focused on aging and chronic diseases)

Since my confirmation on January 27, 2025, I initiated the process to find buyers for these private holdings, but all three assets are privately held investments for which there is no liquid market for their resale. You indicated that you have reviewed these assets, along with duties of my current position as Secretary of the Treasury.¹ Based on your review of these holdings, you have determined that they do not pose a conflict of interest.

Pursuant to this amendment, I will retain my interests in Presight RV Co-Invest Fund, LP and Half Acre WSW, LLC. With regard to each of these entities, I will not participate personally and substantially in any particular matter that to my knowledge has a direct and predictable effect on the financial interests of the entity or its underlying holdings, unless I first obtain a written waiver, pursuant to 18 U.S.C. § 208(b)(1), or qualify for a regulatory exemption, pursuant to 18 U.S.C. § 208(b)(2).

¹ Your review also extended to the International Financial Institution positions to which I was nominated on April 7, 2025: U.S. Governor, International Monetary Fund; U.S. Governor, International Bank of Reconstruction & Development; U.S. Governor, European Bank for Reconstruction & Development; and U.S. Governor, Inter-American Development Bank.

I will also retain my interests in Cambrian Biopharma (Series A and C). I will not participate personally and substantially in any particular matter that to my knowledge has a direct and predictable effect on the financial interests of Cambrian Biopharma, unless I first obtain a written waiver, pursuant to 18 U.S.C. § 208(b)(1), or qualify for a regulatory exemption, pursuant to 18 U.S.C. § 208(b)(2).

I have been advised that this amendment to my ethics agreement will be posted publicly, consistent with the public information law at 5 U.S.C. § 552, on the website of the U.S. Office of Government Ethics with ethics agreements of other Presidential nominees who file public financial disclosure reports.
