#### Gifts from Outside Sources Course of Study

This Course of Study includes an overview of our resources on this topic, including a timely training: Gifts from Outside Sources: A Seasonal Look. In this broadcast, which was designed to be a seasonal refresher on the gift rules, instructors take a look at the gifts analysis process and how to use the first step, the consideration of appearances by the employee, to enhance the culture of ethical decision-making at an agency. They also review the general rule, exclusions, and exceptions for gifts from outside sources, as outlined in Subpart B of the Standards of Ethical Conduct for Employees of the Executive Branch (Standards of Conduct).

## Gifts Between Employees: An Overview of Subpart C

This webinar reviews the restrictions in Subpart C of the Standards of Conduct on gifts between employees. It offers a brief history of the statutory provisions (5 U.S. Code (U.S.C.) § 7351 and its antecedents), as well as an overview of the current regulations and a discussion of some of the most common and recurring questions ethics officials receive. (Please note that this webinar was recorded prior to the 2024 update to the Standards of Conduct, effective August 15, 2024. Among other changes, OGE updated language to make clear that the 5 CFR 2635.302(b)(2) restriction on accepting gifts from employees receiving less pay does not apply to a gift from a superior to a subordinate employee. See 89 Federal Register (FR) 43686 and Legal Advisory (LA)-24-06.)

# Gifts Between Employees in Times of Crisis

This training focuses on the important topic of gifts between employees during times of crisis. It is designed to help ethics officials navigate the complexities of employee gift giving in challenging circumstances and addresses topics covered in <u>LA-24-13</u>.
