Since there is no shortage of novel and challenging entries on OGE Form 450s, the emphasis of these How-To Sessions will be on the research process for analyzing them to help reviewers, especially newer ethics officials or those who will be experiencing their first ever filing season, learn where to locate helpful information and approach their reviews with more confidence.

Also, these How-To Sessions are supplemental to the support OGE already provides to agencies. If an entry you submit is not selected to be analyzed, or you may require an answer sooner than when a How-To Session is scheduled, you should contact ethics officials at your agency or your agency's Desk Officer for assistance. Your agency's Desk Officer is your primary point of contact with OGE.
