## Resources on Pandemic-Related Ethics Issues (Fundraising)

OGE recently issued <u>PA-20-01</u>, which provided suggestions for maintaining ethics program continuity during the disruptions caused by the COVID-19 pandemic. In <u>PA 20-01</u>, OGE suggested that ethics officials explore online resources to help meet education and communication needs. To assist you, OGE plans to distribute compilations of resources that address ethics issues that agencies may face when responding to COVID-19 and/or managing the disruptions caused by the pandemic.

- Crowdsourcing: Pointers and Pitfalls (slides only; this training was not broadcast online). This
  2020 National Government Ethics Summit session discussed ethics concerns surrounding the
  increasingly popular use of crowdsourced fundraising websites. It addressed ethics challenges
  such as screening online donations for prohibited sources and referencing an employee's official
  position on a fundraising website. It also discussed how to apply ethics rules to various common
  crowdsourcing situations, such as fundraisers established by family members and crowdsourcing
  within the Federal workplace.

- Fundraising: Navigating Fundraising and Other Solicitations. In the wake of Hurricanes Katrina and Rita in 2005, OGE convened a Working Group on the Ethical Implications of Emergency Response. One of the products that came out of that working group was a document intended to be used as a tool to navigate the main authorities that may apply to various fundraising and other solicitation events, including the Combined Federal Campaign regulations, various provisions of the Standards of Ethical Conduct, and/or the Federal Management Regulations. In this 30-minute broadcast OGE instructors discuss an updated version of that document, titled Fundraising and Other Solicitations: An Overview of Key Authorities and how it can assist you in determining which authorities to consult when facing a variety of fundraising and other solicitation events.
